# 3. Place of service provided:

Centre for Renewable Sources and Energy Saving – CRES, 19th km Marathonos Avenue, GR 19009, Pikermi, Greece and the whole of Greece according to the project requirements.

## 4. Scope:

The present call refers to the selection of a Contractor for the project "Collection and elaboration of final energy consumption data", which includes the development of statistical studies for the consumption of energy at all end-use sectors (and per field of economic activity). The project shall include the parameterization of the required data to enable the measurement of energy saving, as foreseen in Directive 2006/32/EC and Law 3855/2010. The latter also provides for an indicative national target for energy saving until 2016, through the application of measures for energy efficiency improvement. The project will be implemented within the framework of "National Information System for Measuring Energy Efficiency according to Directive 2006/32", Priority 1 "Improving productivity through the utilization of Information and Communication Technologies" of the Operational Program "Digital Convergence 2007-2013", which has been undertaken by Centre for Renewable Energy Sources and Savings Energy Sources (CRES).

## 5. Funding:

The project is co-funded by ERDF: European Regional Development Fund and National Funds (NATIONAL STRATEGIC REFERENCE FRAMEWORK)

## 6. Project Duration:

The maximum time for implementing the project is set at twenty two (22) months from the signing of the contract.

The Contracting Authority will respond simultaneously to all tenderers' requests made within that period and not later than six (6) days before the deadline of the submission procedure.

# 9. Submission deadline:

Final date and hour for the submission of bids is Friday 18/05/2012, at 12:00 noon, local time.

# 10. Participation:

Eligible to participate in this tender are individuals and legal entities or partnerships or associations of individuals and / or legal entities which operate legally for at least the last five (5) management / financial years and meet the following minimum requirements:

- is/are established in a Member State of the European Union (EU) or
- is/are established in a Member State of the Agreement on the European Economic Area (EEA) or
- is/are established in a Member State which has signed the World Trade Organization's Government Procurement Agreement (GPA) ratified in Greece by Law 2513/97 (GG A139) provided that the contract is covered by GPA - or
- are established in a third country that has concluded European Agreements with the EU or has been established under the laws of a Member State of the Union or EEA, or a Member State which has signed the GPA or a third country which has concluded an agreement with the European Union and which has their central administration or principal place of business or registered office inside one of the above countries which meet the requirements laid down in Article 8 and the Supporting Information Form as well as the minimum participation requirements.
- Do not fall within the prohibitions set by Article 4 of the Law 3310/05 as amended by Law 3414/05.

## Additional info:

Tenderers are required, under penalty of exclusion, to submit a participation letter of guarantee along with their proposal, which should amount to 5% of the available budget VAT included.

# 11. Validity of the bids:

Bids are valid and binding for six (6) months after the deadline for submission of bids. Bids reporting a period of validity of less than six months are rejected as unacceptable.

The validity period of the bids may be extended, after request of the Contracting Authority, by a time period that will not exceed the aforementioned validity period.

## 12. Award Criteria:

The contract will be awarded to the economically most advantageous proposal according to par.1a of article 51 of P.D. 60/2007.

# 13. Available budget:

The maximum allocated budget for the implementation of the project as described in the current Tender is one thousand five hundred and twelve euros (1.219.512 €) plus VAT 23%, namely one million five thousand euros (1.500.000 €) without option.
