



**NEW INTERNATIONAL OPEN PROCEDURE, CALL FOR TENDERS  
FOR THE SELECTION OF A CONTRACTOR FOR THE: "Purchase of equipment  
and supplies for the SHEL project (FCH-JU-2009-1 256837 SHEL)"**

The Centre for Renewable Energy Sources and Saving (CRES), under this invitation to tender, is looking for contractor(s) with demonstrated experience of system development with forklift truck applications, who will provide the following items and services:

1.

*either*

i. **Package 1**: Two (2) FC complete system units (including integrated energy and hydrogen storage, and fuel line components) featuring a suitable power output to feed a reach truck (Class II) FLT capable of handling a load of 1.6 tons (option 1),

*or*

ii. **Package 2**: Three (3) FC complete systems featuring a suitable power output to feed a class I FLT capable of handling a load of 2.5 – 3.0 tons (option 2).

*or*

iii. **Both Packages** in separate offers but in one bid, e.g. one offer for Package 1 AND one offer for Package 2 (option 3).

2. Transportation to CEGASA, Spain (Package 1) or/and Tarsus, Turkey (Package 2);
3. Technical documentation;
4. Training of personnel;
5. Maintenance, servicing, spare parts, warranty.

This tender is foreseen within the framework of the European project, with the title "Sustainable Hydrogen Evaluation in Logistics-SHEL".

The maximum budget amounts to two hundred fifty thousand euros (**250,000 €**) including VAT (where applicable). Award criterion is that of the "**most economically advantageous offer**" according to tender's criteria. NOTE that, CRES will award the contract to the most advantageous offer(s) for the two packages separately, but only in case the total price for both packages is less than the available budget. In case CRES will receive offers for both packages (in any combination of the above options) but the sum up of the two advantageous offers (for 1st & 2nd packages separately) is higher than the budget, then the contract will be awarded for the 1st package's advantageous offer. Any remaining available budget will be used (if applicable) to buy less than three (3) FC complete system units from the 2nd package (from the most advantageous offer for the 2nd package). That's why the bidder, who will provide an offer for the 2nd package, is obliged to fulfil a separate value for the price of one (1) FC system including all other paraphernalia (i.e. storage system, control unit, training, etc.). This value includes all charges and expenses, cannot change for any reason and will be used if such case (as described above) occurs.
