SUMMARY OF THE CALL FOR TENDER

As part of the program entitled **“Rehabilitation of Alexandria Greek Community Complex and Generation Centre of Technology and Sustainable Development in Eastern Mediterranean and Middle East”** which has been laid down by the Hellenic Aid Agency of the Hellenic Ministry of Foreign Affairs in the framework of the international developmental aid, the Centre for Renewable Energy Sources and Saving (CRES) is implementing a project entitled: **«Rehabilitation of the Restaurant Building in the Greek Community Complex in Alexandria»** including **1st Task: Restoration of the Restaurant Building. 2nd Task: Construction of an Extension Linking the Restaurant and the Hostel Building**

Which, respectively, pertains to:

1. The implementation of the revovation of the Restaurant building located in the Greek Community Complex in Chatby, Alexandria according to the studies and specifications given. The renovation includes architectural repairs, structural repairs across and installation of new electromechanical building systems.

2. The implementation of a new lightweight construction which will serve as an enclosed corridor linking the Restaurant to the neighboring Hostel “Manna” building according to the studies and specifications given.
